Dear new and existing member(s)

Welcome to our tennis club. At East Wavertree we have Men's and Ladies team tennis, social tennis on Monday and Wednesday evenings and Thursday, Saturday and Sunday afternoons and we support junior tennis players with special events, coaching and their own social time.

Club members are entitled to a key to the club premises. Please contact myself, Tina darling.

We operate a gift Aid scheme at East Wavertree. This means that the adult subscription for joining the club is at a rate of **£50** but we **suggest** that adult members make a donation of £120. This would make the amount paid by an adult member **£170**. For senior players (65 and over) the rate is **£20** with **£120** donation, making a total of **£140**. Also in order for us to provide the necessary audit trails when claiming the tax relief on donations we need you to complete the enclosed Gift Aid form.

As we are part of a registered charity this allows the club to reclaim 25% of your donation if you are a UK taxpayer. If you were a club member last year we ask that you complete Gift Aid forms for both last season and the forthcoming tennis season. The reason for this is explained in a letter with this pack.

We would also like to inform members who are interested in playing team tennis this season that **match practice** will follow last year's format, with **Men between the hours of 10.30am – 12.30pm** and **Ladies between 12.30pm – 2pm**. Match practice will start on **Sunday 2nd April**. All standards of players are welcome. League team match playing commences week beginning **24th April**.

Please try to return your form as soon as possible as this helps our administration. If you return your form by **Saturday 8th April** your name will be entered into a draw for a £50 Social Club voucher.

If you wish to be considered for league team tennis you **must** return your forms by **Sunday 16th April** to allow the committee sufficient time to register your name.
