Welcome to our tennis club, we look forward to you joining us for a game of tennis in the near future. At East Wavertree we have Men's and Ladies' team tennis, social tennis on Wednesday evenings and Saturday and Sunday afternoons and support junior tennis players with special events, coaching and their own social time.

We operate a Gift Aid scheme at East Wavertree. This means that the adult subscription for joining the club is at a reduced rate of £50 but we ask that members make a donation of **£100 per adult/senior member**. This would make the amount paid by an adult member **£150 in total**.

As we are part of a registered charity this allows the club to reclaim 28% of your donation if you are a UK taxpayer. In order to allow this process to be completed we need all members to make **two separate payments**:

- First cheque: Fee payment - cheques should be made payable to EWLTC
- Second cheque: Donation - cheque should be made payable to EWCCA. (East Wavertree & Childwall Community Association).

Also in order for us to provide the necessary audit trails when claiming the tax relief on donations we need you to complete the enclosed Gift Aid form.

We would also like to inform all members who are interested in playing team tennis this season that **match practice** will follow last year's format, with **Men between the hours of 10.30am – 12.30pm** and **Ladies between 12.30pm – 2pm**. Match practice will start on Sunday 25th March. All standards of players are welcome. Club members are entitled to a key to the club premises.
